2. Roll Call

4. Deletion, correction, adoption of agenda

Commissioner Estwan seconded and the motion carried.

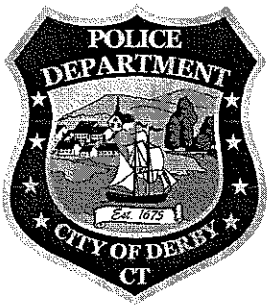
5. Acceptance of Previous Meeting's Minutes

Commissioner Estwan motioned to accept the 15 MAR11 minutes, Commissioner DiSorbo seconded, and the motion carried.

6. Executive Session

The meeting was reopened to the public at 5:45 P.M. following a motion made by Commissioner Estwan and seconded by Commissioner DiSorbo.

Commissioner Estwan motioned to accept the department's recommendation and hire recruit Police Officer Bruce Giovanelli. Commissioner DiSorbo seconded and the motion carried without further discussion. Giovanelli was then sworn in by Commissioner Estwan. He is scheduled to begin training at the Connecticut Police Academy on Friday, April 15th.

7. Old Business

There was no old business discussed.

8. New Business

Detective Robert Donahue retired from the police department on March 31, 2011. The commissioners presented Mr. Donahue with a retired police ID and badge and a Certificate of Recognition for his service to the department.

9. Department Reports

Chief Narowski updated the commissioners on the department's patrol activity. He also reviewed the status of the police department's budget and briefed the commissioners on this past month's department endeavors.

10. Communications

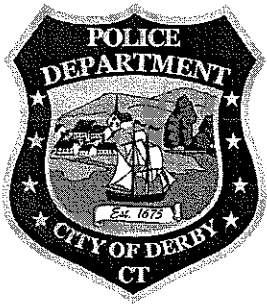
The commissioners were forwarded a letter from the Marcucio family thanking the department for their assistance and participation in the funeral for Nicholas Marcucio.

11. Traffic Authority Business

The Board discussed several items on the LTA report.

The owner of Imperial Liquor requested two time restricted parking spaces in front of his business located at 130 Main Street. Commissioner DiSorbo motioned to accept the recommendation, Commissioner Estwan seconded and the motion carried without further discussion.

After evaluating the impact of making High Street one-way traffic only, the department recommended that the LTA deny this request and keep traffic two-way as is. Commissioner DiSorbo motioned to accept the recommendation, Commissioner Estwan seconded and the motion carried without further discussion.
