7. New Business

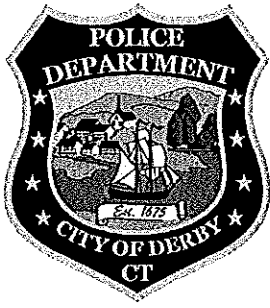
Commissioner Bomba motioned to accept the 2013 Meeting Schedule as presented. Commissioner DiSorbo seconded and the motion passed with all in favor.

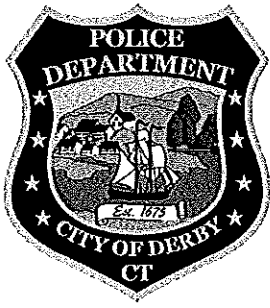
All five officers were sworn in and are expected to begin training at the Connecticut Police Academy on 04 JAN 13.
