4. Executive Session

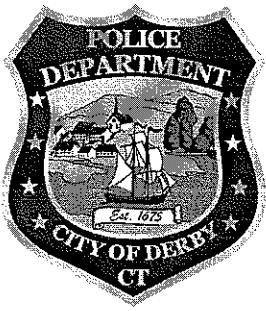

- Discussion and possible action regarding Detective Donahue status as a Police Officer for the City of Derby.
- Discussion and action regarding the promotion of LT Scott Todd to the position of Deputy Chief.

The meeting was reopened to the public at 5:50 P.M. following a motion made by Commissioner DiSorbo and seconded by Commissioner Estwan.

Commissioner Estwan motioned to have Detective Robert Donahue removed from the roster of commissioned police officers effective January 24, 2011 due to his permanent medical restrictions. His retirement date is effective March 31, 2011. (See attached) Commissioner DiSorbo seconded and the motion carried without further discussion.

Commissioner Estwan motion to accept the promotion of LT Scott Todd to the position of Deputy Chief (City charter rank of "Lieutenant"). Commissioner DiSorbo seconded and the motion carried without further discussion.




